

TEXT: Ernest Cline's Ready Player One

DIRECTIONS: Students who are taking English II, whether it is Term 1 or Term 2, will read *Ready Player One* and complete a short, written reflection that responds to the following prompt:

A utopia is a society that is ideally perfect, while a dystopia is an imagined place where the illusion of a perfect society actually masks a world where things have gone horribly wrong. Ready *Player One* is a dystopian novel. Do you see anything in the world today heading in the direction you see in the book?

Students should prepare a brief 1-2 page typed essay response using examples and quotes from the book where appropriate to develop their response. Be sure to format your paper according to <u>MLA guidelines</u> and edit your work using Grammarly before submitting the polished draft to Canvas.
